The sale transaction of bonds with ISIN Code TRSTATK52413, 371-day maturity with a fixed annual interest coupon payment and redemption date May 17, 2024, to be sold to local qualified investors without public offering, was completed on May 11, 2023. The final issuance amount is realized at TL 116.350.000 and annual interest rate at 42%, within the issuance limit approved by the Capital Markets Board's decision dated January 26, 2023 and numbered 4/100. Settlement date for the issuance is May 12, 2023. Yapı Kredi Yatırım Menkul Değerler A.Ş. acted as the broker for this transaction.
